ACT OF ADJOURNAL (RULES FOR LEGAL AID IN CRIMINAL Proceedings Amendmenti 1975

9th May 1975 Made Coming into Operation 16th May 1975

The Lord Justice General, Lord Justice Clerk and Lords Commissioners of Justiciary, by virtue of the powers conferred on them by section 16 of the Legal Aid (Scotland) Act 1967(a) and of all other powers competent to them in that behalf, do hereby enact as follows:

- 1. This Act of Adjournal may be cited as the Act of Adjournal (Rules for Legal Aid in Criminal Proceedings Amendment) 1975 and shall come into operation on 16th May 1975.
- 2. The Act of Adjournal (Rules for Legal Aid in Criminal Proceedings) 1964(b) shall be amended as follows:
 - "1. By deleting from lines 4, 5 and 6 of paragraph 1(2) thereof the words:
 - ""the Act" means the Legal Aid (Scotland) Act 1949 as amended by the Legal Aid Act 1960 and the Criminal Justice (Scotland) Act 1963" and by substituting therefor: ""the Act" means the Legal Aid (Scotland) Act 1967 as amended".
 - 2. By deleting from lines 11 and 12 of paragraph 1(2) thereof the words:
 - "or in a juvenile court constituted in pursuance of section 51 of the Children and Young Persons (Scotland) Act 1937" and by substituting therefor: "or in a district court".
 - 3. By deleting from line 18 of paragraph 1(2) thereof in the definition of "the Regulations" the figures "1964" and by substituting therefor "1975".
 - 4. By deleting from line 20 of paragraph 1(2) thereof in the definition of "the Scheme" the figures "1964" and by substituting therefor "1975".
 - 5. In paragraphs 2(a), 3, 4(1), 5, 6(2), 8(1) and 10(1)thereof all references to "section 2(2)(a)" or "section 2(2)(b)" shall be deleted and there shall be substituted therefor respectively references to "section 2(5)(a)" or "section 2(5)(b) " or " section 2(5)".
 - 6. By deleting from line 2 of paragraph 2(b)(ii) thereof the reference to "section 1(6A)(i)(b)" and by substituting therefor "section 1(7)(a)(ii)".
 - 7. By deleting from line 2 of paragraph 3(2) thereof the words: "a specially constituted juvenile court" and by substituting therefor "the district court".
 - 8. By deleting from line 3 and 4 of paragraph 5(6) thereof the words "and shall send a copy of this certificate to the accused person".
 - 9. By deleting from line 5 of paragraph 8(1) thereof the words: "sheriff court for the district" and by substituting therefor "court".
- 10. By deleting from line 7 of paragraph 8(1) and from line 2 of paragraph 8(2) thereof the word "sheriff".
- 11. By deleting from line 3 of paragraph 10(1)(e) thereof the reference to "section 2(1A)" and by substituting therefor " section 2(2)".
- 12. By deleting from lines 7 and 8 of paragraph 10(3)(a) thereof the reference to "section 1(6A)(ii)" and by substituting therefor "section 1(7)(b)".
 - 13. By deleting paragraph 14.

AMENDMENT) 1975

Made ... 9th May 1975 Coming into Operation 16th May 1975

The Lord Justice General, the Lord Justice Clerk and the Lords Commissioners of Justiciary, under and by virtue of the powers conferred upon them by section 16 of the Legal Aid (Scotland) Act 1967(a), and of all other powers competent to them in that behalf, do hereby enact and declare as follows:

- 1. This Act of Adjournal may be cited as the Act of Adjournal (Criminal Legal Aid Fees Amendment) 1975, and shall come into operation on 16th May 1975.
- 2. The Act of Adjournal (Criminal Legal Aid Fees) 1964(b), as amunded by the Act of Adjournal (Criminal Legal Aid Fees Amendment) 1965(c), by the Act of Adjournal (Criminal Legal Aid Fees Amendment) 1968(d), by the Act of Adjournal (Criminal Legal Aid Fees Amendment) 1971(e) and by the Act of Adjournal (Alteration of Criminal Legal Aid Fees) 1973(f) shall be further amended as follows:
 - "1. By deleting from lines 4, 5 and 6 of paragraph 2(1) thereof the words "the Act" means the Legal Aid (Scotland) Act 1949 as amended by the Legal Aid Act 1960 and the Criminal Justice (Scotland) Act 1963"; and by substituting therefor: "the Act" means the Legal Aid (Scotland) Acts 1967 as amended".
 - 2. By deleting from line 24 of paragraph 2(1) thereof in the definition of "the Regulations" the figures "1964" and by substituting therefor "1975".
 - 3. By deleting from line 26 of paragraph 2(1) thereof in the definition of "the Scheme" the figures "1964" and by substituting therefor "1975".
 - 4. By deleting from paragraph 2(1) thereof the last sentence which begins with the words ""the Sheriff Court" shall...".
 - 5. By inserting in line 2 of paragraph 3(1) and line 4 of paragraph 15(2) thereof between the words "sheriff" and "court" the words: "or district".
 - 6. By deleting from lines 2 and 3 of paragraph 4 thereof the words "in the sheriff court".

And the Lords appoint the Act of Adjournal to be recorded in the Books of Adjournal, and to be published in the Edinburgh Gazette.

STATUTORY INSTRUMENTS 1975 No. 837 (S. 144)

SUMMARY JURISDICTION, SCOTLAND

ACT OF ADJOURNAL (SUMMARY PROCEDURE) 1975

Made ... 9th May 1975 Coming into Operation 16th May 1975

The Lord Justice General, Lord Justice Clerk and Lords Commissioners of Justiciary, by virtue of the powers conferred upon them by section 76 of the Summary Jurisdiction (Scotland) Act 1954(a) as amended (b), and of all other powers competent to them in that behalf, do hereby enact as follows:

1. This Act of Adjournal may be cited as the Act of Adjournal (Summary Procedure) 1975, and shall come into operation on 16th May 1975.

- 2. In every Appeal to the High Court of Justiciary in summary procedure whether by Stated Case under the provisions of Section 62 of the Summary Jurisdiction (Scotland) Act 1954 or by suspension or otherwise, if the solicitor acting for any party loes not practise in Edinburgh it shall be the duty of that solicitor to appoint an Edinburgh solicitor, hereinafter referred to as "the Edinburgh solicitor", who will be responsible to the High Cour for the due execution of all duties relative to procedure in the Appeal which fall to be carried out by the solicitor for such party.
- 3. The duty laid upon an Appellant under the provisions of Sub-s ction 4) of Section 67 of the Summary Jurisdiction (Scotland) Act 1954 shall, unless an Appellant has no solicitor, be carried out by the Edinburgh solicitor who shall lodge the Stated Case and the relative Certificate of Intimation, along with an appropriate Inventory of Process, and shall pay the prescribed fee.
- 4. It shall be the duty of the Edinburgh solicitor acting for any Respondent to a tend at the Justiciary Office and enter app arance as soon as he shall have received instructions in terms of Section 2 of this Act of Adjournal.
- 5. The Clerk of Just'clary shall from time to time after such consul a ion with the Lord Justice General or Lord Justice Clerk as may be necessary, issue a list of cases for disposal with the diet fix d for their hearing on the Justiciary Roll and shall give to the Edinburgh solicitors for the parties at least four can days no ic of the date fixed for the hearing.
- 6. It shall be the duty of the Edinburgh solicitor acting for the Appellant in an appeal by Stated Case or for the Complainer in an appeal by Suspension or Advocation, or of the Appellant or Complainer personally if he has no professional representation, to arrange for the printing of the Stated Case or Bill and the relative complaint and proceedings before the Inferior Court and, not later than seven days before the date fixed for the hearing, to return the process to the Clerk of Justiciary and to furnish to the Clerk of Justiciary for the use of the Court, and to the Edinburgh solicitor for the Respondent copies of the print of the Appeal and proceedings in conformity with current practice.

- 7. If a party who has no solicitor, or the Edinburgh solicitor, finds that for any reason it is not possible within the appropriate time to comply with the provisions of the foregoing section he shall, not later than seven days before the date fixed for the hearing, intimate the reason for such failure to comply to the Clerk of Justiciary who may at his discretion allow the case to drop from that Roll, or may take no action.
- 8. If the case is not allowed to drop from the Roll in terms of the immediately preceding section, the Court shall, at the diet of hearing, decide what should be done in the circumstances, and may dismiss the Appeal.
- 9. An Edinburgh solicitor who presents to the Clerk of Justiciary a Bill of Suspension or of Suspension and Liberation with a request for a First Deliverance shall, if he is not at the time of presentation nominated as Edinburgh solicitor in a full Appeal Certificate granted under the provisions of Section 21(1)(a) of the Legal Aid (Scotland) (Criminal Proceedings) Scheme, 1964, being the Scheme made under section 8 of the Legal Aid (Scotland) Act 1967(a) be personally responsible to the Court for the performance of the obligations, including the obligation to provide prints, specified in Section 6 of this Act of Adjournal. The Clerk of Justiciary shall in appropriate cases draw to the attention of any solicitor presenting a Bill in which an Appeal Certificate has not been granted the provisions of this section.
- 10. Where a Bill contains inter alia a prayer for suspension ad interim of any order, or for interim liberation, it shall be competent for the judge before whom such Bill is laid for a First Deliverance, if he shall think fit, to hear Counsel for the parties on the interim prayer either before the grant of such First Deliverance or at any time subsequent thereto.
- 11. No order for suspension ad interim or for interim liberation shall take effect until the Bill shall have been served on the Respondent and the principal thereof exhibited to the Clerk of the Inferior Court.
- 12. It shall be the duty of the Clerk of any Inferior Court in any proceedings by Bill of Suspension to engross on the principal of the Bill when it is exhibited to him a certificate as to the appropriate exhibition, and if caution for interim liberation be then found, as to the finding of such caution. When caution for interim liberation is found at any time after the exhibition of the Bill to the Clerk of the Inferior Court,

that Clerk shall forthwith intimate to the Clerk of Justiciary that caution has been found and that the Complainer has been liberated.

ACT OF ADJOURNAL (HIGH COURT SITTINGS AND JURIES) 1975 9th May 1975 Made Coming into Operation 16th May 1975

The Lord Justice General, the Lord Justice Clerk and Lords Commissioners of Justiciary by virtue of the powers conferred upon them by Sections 7 and 8 of the Juries (Scotland) Act 1825(a) as amended, Section 2 of the Act of 39 and 40 Victoria, Chapter 152, Section 1 of the Circuit Courts and Criminal Procedure (Scotland) Act 1925(b) and all other powers competent to them in that behalf, do hereby enact and declare as follows:—

- 1. This Act of Adjournal shall be known as the Act of Adjournal (High Court Sittings and Juries) 1975 and shall come into operation on 16th May 1975.
- 2. Sittings of the High Court of Justiciary on Circuit and at Edinburgh shall be kept as hitherto at the places specified in Columns I and II of the Schedule attached hereto.
- 3. The Circuit kept at Stirling shall be disjoined from the Western Circuit and shall hereafter form part of the Northern Circuit.
- 4. The area of territorial jurisdiction of the Circuit kept at each place or exclusively attached to the High Court of Justiciary sitting at Edinburgh as the case may be shall consist of the Sheriff Court Districts as defined in the Sheriff Courts Districts Reorganisation Order 1975(c) shown in Column III of the said Schedule as being applicable to that circuit place or to Edinburgh.
- 5. The functions of the Sheriff Clerk of each Shire, and of the Sheriff Clerk of the Sheriffdoms, as designed by Sections (2) and (3) of the Act of Adjournal of 3rd November 1887, shall be performed for each circuit place by the Officer in charge of the Sheriff Clerk's Office at that place.
- 6. The number of jurors to be summoned as provided by sections 7 and 8 of the said Juries (Scotland) Act shall be, for each Sheriff Court area, those specified for that area in Column IV of the said Schedule; provided that if the Clerk of Justiciary shall requisition fewer or more than forty-five the numbers to be summoned shall be diminished or increased in proportion as the case may be.
- 7. In this Act any reference to any enactment shall be construed as a reference to that enactment as amended or extended by or under any other enactment. And the Lords appoint this Act to be published in the Edinburgh Gazette and entered in the Books of Adjournal.

(Made 13th February 1975)

This order, which came into operation on the 21st March, is made under the Diseases of Animals Act 1950, revokes and replaces with amendments the Regulation of Movement of Swine Order 1959 and the Movement of Pigs (Waste Food Precautions) Order 1973.

The principal provisions of the order as as follows:

- (1) A prohibition is introduced prohibiting the movement of pigs off premises within 21 days of the movement of any pigs onto those premises. This prohibition however does not apply in the case of premises which are a market, fairground, saleyard, licensed collecting centre, artificial insemination centre, performance testing station, exhibition or show, or in the case of a number of exempted movements specified in the order. (Article 2).
- (2) Movement of pigs from all premises is made subject to licensing control with the exception of certain specified movements. In the case of a movement from premises where waste food is kept, and a movement from a slaughter market, a licence may only be issued for a movement to a slaughterhouse. (Articles 3, 4 and 5).
- (3) Before movement to a slaughterhouse or to a slaughter market pigs must be marked on the back with a red cross as specified in the order. (Article 7).

STATUTORY INSTRUMENTS 1975 No. 143

The Brucellosis (Berkshire, South-West Oxfordshire, Surrey, Etc. Eradication Area) Order 1975

(Made 5th February 1975)

Under section 5 of the Diseases of Animals Act 1950, the Minister of Agriculture, Fisheries and Food may make orders declaring an area to be an eradication area for purposes connected with the control of any disease of cattle if he is satisfied that a substantial majority of the cattle therein are free from that disease. Under the same section, as extended by section 106(3) of the Agriculture Act 1970, the Minister may make orders imposing such prohibitions or requirements with respect to cattle in eradication areas as he may consider necessary or desirable for the purpose of eradicating brucellosis.

The present order, which came into operation on the 3rd March, declares a further area in England to be an eradication area, and prohibits the vaccination against brucellosis of cattle in that area, unless undertaken on behalf of the Minister, or under a licence issued by a veterinary inspector employed by him. The area concerned is:

The county of Berkshire, together with the south-west part of Oxfordshire, and the county of Surrey, together with a small area of West Sussex and the western and southern parts of Greater London.

The order also provides that the provisions of the Brucellosis (Area Eradication) (England and Wales) Order 1971, as amended, shall come into effect in that area, as from 1st November 1975.
