OFFSHORE PETROLEUM DEVELOPMENT (SCOTLAND) ACT 1975 DESIGNATED SEA AREA INNER SOUND OF RAASAY

THE Secretary of State hereby gives notice, that in terms of Section 3 of and Schedule 3 to the Offshore Petroleum Development (Scotland) Act 1975 he proposes to make a sea designation order providing for the making of a Designated Sea Area in the Inner Sound of Raasay, all of Loch Carron and Loch Kishorn, and part of Loch Alsh. The Designated Sea Area extends to a line north of the Inner Sound of Raasay and between the northern tip of the Isle of Rona (NG 630 617) and Rubha na Fearn (NG 721 615), it includes all of Loch Carron and of Loch Kishorn, and it extends as far east in Loch Alsh as the line from a point on the shore of the loch between Donald Murchison's monument and Balmacara House (NG 793 272) and Rubha Buidhe (NG 793 253).

The purpose of the Designation is to enable the Secretary of State to facilitate or control the execution of operations relating to the exploration for and exploitation of offshore petroleum.

RADIOACTIVE SUBSTANCES ACT 1948 PROPOSAL TO AMEND THE RADIOACTIVE SUBSTANCES (ROAD TRANSPORT WORKERS) (GREAT BRITAIN) REGULATIONS 1970

MISUSE OF DRUGS ACT 1971 DIRECTION PROHIBITING EXERCISE OF POWERS IN RELATION TO CONTROLLED DRUGS HENRY JOSEPH CARON

IN accordance with Section 12(2) of the Misuse of Drugs Act 1971, notice is hereby given that the Secretary of State gave the following direction which was served and thereby came into effect on 23rd June 1975:—
