#### PIPE-LINES ACT 1962 NOTICE OF APPLICATION FOR A PIPELINE CONSTRUCTION AUTHORISATION

BP TRADING LIMITED and IMPERIAL INDUSTRIES LIMITED hereby give Notice that subsequent to their application to the Secretary of State for the grant of an authorisation for the construction of a cross-country pipeline to convey ethylene between the Works of ICI at Wilton, Cleveland and the Works of BP at Grangemouth of which notice was given in accordance with the provisions of Part I of the First Schedule to the Pipe-lines Act 1962 in April 1975, they have indicated to the Secretary of State that they request that if an authorisation is granted it shall authorise the placing of the works for the said pipeline along a modified route as hereinafter stated.
