WESTMINSTER-JULY 18, 1812.

This day the Lords being met, a message was sent to the Honourable House of Commons by the Yeoman Usher of the Black Rod, acquainting them, that The Lords, authorized by virtue of a Commission under the Great Seal, signed by the Prince Regent, in the name and on the bebalf of his Majesty, for declaring his Majesty's Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers, to bear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An act for advancing two millions five hundred thousand pounds to the East India Company, to enable them to discharge part of the Indian debt.

An act for better securing the duties on malt.

An act for amending two acts passed in the forty-eighth and forty-ninth years of his present Majesty, for enabling the Commissioners for the reduction of the national debt to grant life-annuities.

An act to repeal the several acts for the collection

An act to repeal the several acts for the collection and management of the stamp-duties in Ireland, and to make more effectual regulations for collecting and man-

make more effectual regulations for collecting and managing the said duties.

An act for the more effectual punishment of persons destroying the properties of his Majesty's subjects, and enabling the owners of such properties to recover damages for the injury sustained.

An act to prohibit until the first day of November 1812, the making of starch, hair-powder, and blue, from wheat, and other articles of food, and for suspending part of the duties now payable on the importation into Great Britain of starch.

An act to exempt from the duties of one shilling and of sixpence in the pound, certain augmentations made to the stipends of parishes in Scotland.
