## CARLTON-HOUSE—JULY 17, 1812.

His Royal Highness the Prince Regent was this day pleased to confer the honour of Knighthood on William Garrow, Esq. his Majesty's Solicitor-General.

## WESTMINSTER—JULY 18, 1812.

This day the Lords being met, a message was sent to the Honourable House of Commons by the Yeoman Usher of the Black Rod, acquainting them, that *The Lords, authorized by virtue of a Commission under the Great Seal, signed by the Prince Regent, in the name and on the behalf of his Majesty, for declaring his Majesty's Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers, to bear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to*

An act for advancing two millions five hundred thousand pounds to the East India Company, to enable them to discharge part of the Indian debt.

An act for better securing the duties on malt.

An act for amending two acts passed in the forty-eighth and forty-ninth years of his present Majesty, for enabling the Commissioners for the reduction of the national debt to grant life-annuities.

An act to repeal the several acts for the collection and management of the stamp-duties in Ireland, and to make more effectual regulations for collecting and managing the said duties.

An act for the more effectual punishment of persons destroying the properties of his Majesty's subjects, and enabling the owners of such properties to recover damages for the injury sustained.

An act to prohibit until the first day of November 1812, the making of starch, hair-powder, and blue, from wheat, and other articles of food, and for suspending part of the duties now payable on the importation into Great Britain of starch.

An act to exempt from the duties of one shilling and of sixpence in the pound, certain augmentations made to the stipends of parishes in Scotland.

And to several English acts, and five private acts.

## JULY 20, 1812.

An act for extending the time for the payment of certain sums of money advanced, by way of loan, under an act passed in the last session of Parliament, for enabling his Majesty to direct the issue of Exchequer bills, to a limited amount, for the purposes and in the manner therein mentioned.

An act for the further prevention of the counterfeiting of silver tokens issued by the Governor and Company of the Bank of England, called dollars, and of silver pieces issued and circulated by the said Governor and Company, called tokens, and for the further prevention of frauds practised by the imitation of the notes or bills of the said Governor and Company.
