DISEASES OF ANIMALS ACT 1950 THE DISEASES OF ANIMALS (APPROVED DISINFECTANTS) (AMENDMENT) (No. 2) ORDER 1976

The order also extends until 31st January 1977 the period for which disinfectants approved in respect of swine vesicular disease, and listed in Section 2 of Part I-B, shall remain approved.

Provision is also made for the continued use of approved disinfectants now deleted from the Schedule for a transitional period from the coming into operation of this order until 31st December 1976.
