HERRING INDUSTRY BOARD DIRECTION No. 2/76

THE Herring Industry Board by virtue of the powers vested in them by the Herring Industry Scheme 1951 hereby make the following Direction:—

Between the 6th day of September 1976 and the 26th day of March 1977 (both dates inclusive) no person shall sell or buy herring on a first sale at sea nor transport herring to land and sell on a first sale at places in the Outer or Inner Hebrides or on the west coast of the mainland of Scotland north of Crinan other than Oban, Mallaig, Ullapool, Uig, Stornoway and Loch Boisdale; provided that this Direction shall not apply in respect of (i) herring landed by vessels not exceeding 35 feet in length overall where the quantity landed on any day by any such vessel is not more than 18 units of 100 kg. or (ii) herring comprised in a vessel's catch of sea fish and not exceeding 10% by weight of that catch.

For the purpose of this Direction "to land" shall mean discharge on to a quay or on to a vessel.

THE TRUNK ROADS (GALASHIELS) (RESTRICTION OF WAITING) ORDER 1976

THE Secretary of State gives notice that he proposes to make an order imposing additional and amended waiting restrictions on length of the trunk road (Route A.7) in Galashiels from the south west kerbline of Ladhope Vale to a point 197 yards south east of the junction with Cornmill Square and from the junction of Channel Street with High Street to a point on Market Street 20 yards south of Green Street.
