THE COUNSELLORS OF STATE IN COUNCIL

WHEREAS Her Majesty, in pursuance of the Regency Acts 1937 to 1953, was pleased, by Letters Patent dated the 29th day of June 1976, to delegate to the six Counsellors of State therein named or any two or more of them full power and authoraty during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to signify thereat Her Majesty's approval for anything for which Her Majesty's approval in Council is required:

And whereas the Secretary of State has, in pursuance of the powers competent to him under Section 5 of the Burial Grounds (Sootland) Act 1855 (1855c 68) made a Representation that he has received a copy of an Interlocutor dated the 17th day of March 1976, pronounced by the Sheriff of the Sheriffdom of North Strathclyde at Greenock finding that continued use of the Burial Ground known as Inverkip Street Cemetery (formerly known as the Duncan Street Burying Ground), Greenock in the Desinct of Inverclyde, as a place of interment would be offentive or contrary to decency:

And whereas in the said Representation it is recommended but in terms of Section 5 of the aforesaid Act burials be disconnected forthwith in the said Burial Ground:

Now, therefore, Her Majesty Queen Elizabeth The Queen Mother and His Royal Highness The Prince Charles, Prince of Vales, being authorised thereto by the said Letters Patent and

in pursuance of the powers conferred upon Her Majesty by the aforesaid Act do hereby by and with the advice of Her Majesty's Privy Council, on Her Majesty's behalf give Notice of the said Representation and order that the same be taken into consideration on the 30th day of September next.

And do further direct that this Order, or notice thereof, be published in the Edinburgh Gazette and that copies of this Order or notice thereof, be fixed as required by the said Act on the doors of the Church of, or on some other conspicuous place within, the parish affected by such Representation one month before such Representation is so considered.

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 13th August 1976, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £600,000,000.

- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday the 16th August 1976 to Friday the 20th August 1976 inclusive and will be due 91 days after date.
 - 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent, (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

WAGES COUNCILS ACT 1959 EMPLOYMENT PROTECTION ACT 1975

Ostrich and Fancy Feather and Artificial Flower Wages Council (Great Britain)

- 2. The following diseases have never been recorded in Great Britain: African horse sickness (pestis equorum), African swine fever (pestis suum africana), blue tongue (febris catarrhalis ovium), dourine (exanthema coitale paralyticum), equine encephalomyelitis (meningo-encephalomyelitis enzootica eq.), lumpy skin disease (dermatosis nodularis) and Teschen disease (encephalomyelitis enzootica suum).
