TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 7th January 1977, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £300,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday the 10th January 1977, to Friday, the 14th January 1977 inclusive, and will be due 91 days after date.
 - 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of

such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

WAGES COUNCILS ACT 1959 EMPLOYMENT PROTECTION ACT 1975 LAUNDRY WAGES COUNCIL (GREAT BRITAIN)

the preliminary draft of regulations entitled The Social Security (Non-Contributory Invalidity Pension) Amendment Regulations 1977

A short explanatory note on these regulations is appended to this notice. The Committee will take into consideration any objections made by or on behalf of persons affected, received by them not later than 4th February 1977. EXPLANATORY NOTE

These regulations contain provisions relating to women who are entitled to non-contributory invalidity pension if they are incapable both of work and of perfoming normal household duties.

The Social Security Act 1975 lays down the incapacity conditions for non-contributory invalidity pension which must be satisfied by any married woman who is living with her husband (or who is being maintained by him to at least the weekly rate of the pension), or by any woman who is co-habiting with a man as his wife. Any such woman who is incapable of personing normal household duties, as well as being incapable of paid work, shall be entitled to non-contributory invalidity pension. These regulations prescribe the circumstances in which a woman shall be regarded as being incapable of personing normal household duties and deal with certain related matters.
