TENDERS FOR TREASURY BILLS

1. THE TRUNK ROADS (AUCHINLECK) (PROHIBITION OF WAITING) ORDER 1977

THE Secretary of State gives notice that he proposes to make an order which will revoke the Trunk Roads (Auchinleck) (Prohibition of Waiting) Order 1969 and re-impose and extend the existing restrictions on the trunk road (Route A.76) at Auchinleck between the junction with Market Road and a point 69 metres south of the junction with Church Hill. The order will provide exceptions to enable a vehicle to wait for as long as may be neccessary for a person to board or alight, to enable goods to be loaded or unloaded, and to be used in connection with maintenance operations and other works. Disabled persons would also be exempted.
