generally north westerly direction (including the slip roads adjoining the Raigmore Interchange (Route A96) but excluding the roundabout) to a point immediately north of the northern junction of the Longman Roundabout, a distance of 6.7 kilometres or thereby;

3. Tore to Findon section—from a point 250 metres or thereby west of the junction of Route A832 and Route B9162 in a generally northerly direction to a point 60 metres or thereby south east of the junction with Route B9163, a distance of 8.1 kilometres or thereby; and

4. Findon-Ardullie section—from a point 60 metres or thereby south east of the junction with Route B9163 in a generally northerly direction to a point immediately north of the northern junction of the Ardullie Roundabout, a distance of 2.4 kilometres or thereby. The orders will come into operation on the completion of the trunk road improvements.

Full details are contained in the draft orders which, together with a statement of the Secretary of State's reasons for proposing to make the orders and plans showing the lengths of road involved may be examined, during normal office hours at:—

THE TRUNK ROADS (ROUTE A85) (LOCHAWAY)
(TEMPORARY WEIGHT RESTRICTION)
ORDER 1977

THE Secretary of State gives notice that he has made the above order revoking the Trunk Road Route A85) (Temporary Weight Restriction) Order 1973 and imposing a 15 ton weight restriction on that length of the Tyndrum-Oban Trunk Road (Route A75) in the Strathclyde Region from a point 200 metres east of the access to Airc Crossig eastwards to the west end of the Cruachan Viaduct, a distance of 1,200 metres or thereby, as the carrying capacity of this length of road is now suspect.
