DENMARK: OFFICIAL CERTIFICATE

NETHERLANDS: OFFICIAL CERTIFICATE

THE Secretary of State for Scotland gives notice that in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1968 as amended by the Imported Food (Scotland) Amendment Regulations 1973 he hereby restricts recognition of (1) the Official Certificates reproduced in the Schedules to the Notice published in the *Edinburgh Gazette* dated 29th March 1938 and 19th February 1965 for the importation from the Netherlands of meat products and bacon and (2) the Official Certificate reproduced in the Schedule to the Notice published in the *Edinburgh Gazette* dated 14th September 1973 for the importation from the Netherlands of meat (including bacon), to the extent shown in the Schedule hereto.
