- (iv) Earl Grey Street (west side)
- (v) Lothian Road (west side)

The With-Flow Bus Priority Lanes will be in operation (except on public holidays) between the hours of 8 a.m. and 9.15 a.m. and between 4.30 p.m. and 6.00 p.m. on Mondays to Fridays both inclusive. During these hours no vehicles other than a stage carriage, scheduled express carriage, school bus, or works bus may enter or proceed in a with-flow bus priority lane and no vehicles other than a stage carriage or scheduled express carriage may wait in a with-flow bus priority lane.

Exemptions and exceptions provide for essential and public services, traffic emergencies, vehicles engaged in building, demolition or excavation operations in or adjacent to a with-flow bus priority lane, pedal cycles, postal services, vehicles crossing a with-flow bus priority lane for the purpose of access to or egress from premises fronting such with-flow bus priority lane, boarding or alighting from vehicles, loading or unloading of personal luggage, funeral undertakings, removal of furniture to or from one office, dwellinghouse or depository adjacent to a with-flow bus priority lane from or to another office,

dwellinghouse or depository and collection or delivery of goods from or to premises in or adjacent to a with-flow bus priority lane if the goods cannot reasonably be loaded or unloaded outwith the aforementioned hours of operation of such with-flow bus priority lane.

#### B. Creation of Contra-Flow Bus Priority Lane

A contra-flow Bus Priority Lane is created in Bread Street, Edinburgh (south side) with buses travelling along the contra-flow bus priority lane in a westerly direction only.

The contra-flow bus priority lane will be in operation at all times and pedal cycles are not permitted to enter, proceed or wait in it. Apart from the foregoing variations the provisions regarding the operation of the contra-flow bus priority lane during peak hours viz: between the hours of 8.00 a.m. and 9.15 a.m. and between 4.30 p.m. and 6.00 p.m. on Mondays to Fridays both inclusive (excepting public holidays) are the same as those governing the operation of the with-flow bus priority lanes.

At all times apart from peak hours the provisions regarding the operation of the contra-flow bus priority lane are the same as those applicable to peak hours with the exception of the provision relating to access for vehicles collecting or delivering goods which is that vehicles in actual use in connection with the collection or delivery of goods from or to premises in or adjacent to the contra-flow bus priority lane are permitted to enter, proceed and wait in the contra-flow bus priority lane (subject to the provisions of the Order and any other enactment as defined therein).

#### C. Prohibition of Right-Hand Turns from Roads in Edinburgh

The Order provides for the prohibition of right-hand turns for vehicular traffic as follows:—

- (a) From Lothian Road into King's Stables Road;
- (b) From that portion of Fountainbridge commonly known as East Fountainbridge into Lothian Road;
- (c) From West Port into Lauriston Street;
- (d) From Spittal Street into Bread Street (except for stage carriages, scheduled express carriages, school buses and works buses).

#### D. Prohibition of Left-Hand Turns from Roads in Edinburgh

The Order provides for the prohibition of a left-hand turn for vehicular traffic from South Charlotte Street into Princes Street.

#### E. Mandatory Left-Hand Turns from Roads in Edinburgh

The Order provides for vehicles proceeding in a westerly direction along Bread Street to make a mandatory left-hand turn from Bread Street into Lothian Road at the junction of these roads.

#### F. One-Way Roads in Edinburgh

The Order provides for the roads or parts thereof specified in column 1 below to be one-way only for vehicular traffic and that in the direction specified in column 2 below.
