NOTICE is hereby given that the Western Isles Islands Council is to apply to the Secretary of State for Scotland for an Order under Section 21 of the Water (Scotland) Act 1946, the effect of which, if made, will be to enable the Council to take water from the Maarug River, Harris, for the purpose of supplying water to the township of Maarug.

The area covered by the Order is wholly within the Western Isles Islands Area.

THE DUMFRIES AND GALLOWAY REGIONAL COUNCIL (HOWGATE, PRIMROSE AND BREWERY STREETS, DUMFRIES) (WAITING RESTRICTIONS) ORDER 1978

1. THE Dumfries and Galloway Regional Council propose to make an Order in exercise of powers contained in Sections 1(1), (2), (3), (3c) and 84D(1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Section 133 of and Schedule 14 to the Local Government (Scotland) Act 1973 and Section 24(2) of and Schedule 6 to the Road Traffic Act 1974 and of all other enabling powers.
2. The effect of the Order will be to prohibit the waiting of vehicles at the specified times on the following lengths of road:—

No Waiting at any time

Howgate Street	on the north side from a point 7 metres (8 yards) or thereby east of its junction with Galloway Street to a point 62 metres (68 yards) or thereby east of that junction.
Primrose Street	on both sides from the junction with Church Street to a point 26 metres (28 yards) or thereby south west of that junction.

No Waiting Monday-Saturday 8 a.m.-6 p.m.

Brewery Street	on the north east side from a point 23 metres (25 yards) northwest of the junction with Friars Vennel to a point 41 metres (45 yards) or thereby north-west of that junction.

Limited Waiting-20 minutes in any hour Monday-Friday 8 a.m.-6 p.m.

Brewery Street on the north east side from a point 41 metres (45 yards) north west of the junction with Friars Vennel to a point 57 metres (62 yards) or thereby north-west of that junction.

3. Exceptions will permit waiting for the purposes of:—
 - (a) picking up and setting down passengers;
 - (b) road maintenance and public utility works;
 - (c) enabling goods to be loaded on to or unloaded from the vehicle; and
 - (d) designated disabled drivers.
4. Full details of these proposals are in the draft Order which, together with maps showing the affected lengths of road and a Statement of the Council's reasons for proposing to make the Order are available for inspection during normal office hours at Regional Council Offices, Dumfries.
