THE Secretary of State gives notice that he has made the following Orders: ----

- 1. An Order for the construction of new lengths of road to form part of the London-Carlisle-Glasgow-Inverness Trunk Road (A82) between Carnoch and Craigrannoch in Highland Region.
- 2. An Order for (a) the construction of new lengths of road to provide connections with the new trunk road (b) the stopping-up of the superseded length of the existing London-Carlisle-Glasgow-Inverness Trunk Road (A82) north of Fraser's Tea Rooms.

The works authorised in these two Orders form part of the draft Orders published in 1973 entitled the Connel-Glencoe Trunk Road (Ballachulish and West of St John's Church Diversions) Order 197. These original Orders were the subject of a public local inquiry held in St John's Church Hall, Laroch on the 18th January 1977.

Copies of the London-Carlisle-Glasgow-Inverness Trunk Road (Carnoch-Craigrannoch Stage 1 Diversions) Order 1978 can be purchased through any bookseller or direct from Her Majesty's Stationery Office, 13A Castle Street, Edinburgh.

Copies of both Orders and relative plans have been deposited at the offices of the Scottish Development Department, New St. Andrew's House, St. James Centre, Edinburgh and the offices of the Highland Regional Council, Regional Buildings, Glenurquhart Road, Inverness.

Any person aggrieved by the Orders and desiring to question the validity thereof, or of any provision contained therein, on the grounds that they are not within the powers of the Trunk Roads Act 1946, the Special Roads Act 1949 and the Roads (Scotland) Act 1970 as applicable, or on the grounds that any requirement of the said Acts, or of any regulations made thereunder, have not been complied with in relation to the Orders may within 6 weeks of 21st December 1978 apply to the Court of Session for the suspension or quashing of the Orders or of any provision contained therein.

Any owner and tenant of property likely to be affected by the proposals may obtain an explanatory leaflet on application to the Department or Highland Regional Council.
