

**COMPENSATION FOR
AIRCRAFT AND SHIPBUILDING INDUSTRIES**

ON behalf of Her Majesty's Treasury the Bank of England announce that, in accordance with the Aircraft and Shipbuilding Industries Act 1977, an issue of about £1.09 million of 9½% Treasury Stock 1981 was made on 18th June 1979 as a further payment on account of compensation in respect of the unquoted securities of Scottish Aviation Limited. This follows the announcement on 1st June 1979 by the Department of Industry.

In accordance with the same Act, an issue of about £0.96 million of 9½% Treasury Stock 1981 was also made on the same day as compensation due in respect of the unquoted securities of Hawthorn Leslie (Engineers) Limited. This follows the announcement on 5th June 1979 by the Department of Industry and the Stockholders' Representative that compensation had been agreed.

Both issues of 9½% Treasury Stock 1981 were made at the rate of £100 Treasury Stock per £96 3/16 compensation on account.

The Stock issued will rank for a full 6 months' interest on 1st October 1979 and will not be distinguished from 9½% Treasury Stock 1981 already in being.

A special interest payment will be made, in the case of the securities of Scottish Aviation Limited, covering the period from 29th April 1977 to 1st April 1979 and, in the case of the securities of Hawthorn Leslie (Engineers) Limited covering the period from 1st July 1977 to 1st April 1979.

Dealings in the stock issued on 18th June 1979 commenced on 19th June 1979.
