**TENDERS FOR TREASURY BILLS**

1. **COMPENSATION FOR AIRCRAFT AND SHIPBUILDING  
INDUSTRIES**

ON behalf of Her Majesty's Treasury the Bank of England announce that, in accordance with the Aircraft and Shipbuilding Industries Act 1977, an issue of about £4.25 million of 10% Exchequer Stock 1983 was made on 14th October 1980 as compensation due in respect of the unquoted securities of Vosper Thornycroft (U.K.) Limited and Vosper Ship-repairers Limited.
