THE STIRLING-CALLANDER-CRIANLARICH TRUNK ROAD (A85) (BENMORE DIVERSION) COMPULSORY PURCHASE ORDER 1981

NOTICE is hereby given that the Secretary of State, in exercise of the powers conferred on him by the above-mentioned Acts, on the 3rd day of February 1981 made a Compulsory Purchase Order entitled The Stirling-Callander-Crianlarich Trunk Road (A85) (Benmore Diversion) Compulsory Purchase Order 1981.

The Order provides for the purchase of the land described in the Schedule hereto for the purpose of the construction a new length of trunk road at Benmore.

A copy of the Order as made and of the map referred to therein have been deposited at the offices of the Scottish Development Department, New St. Andrew's House, Edinburgh and the Central Regional Council, Viewforth, Stirling FK8 2ET and may be seen there without payment of fee during business hours.

The Order as made becomes operative on the 20th February 1981 being the date on which this notice is first published ; but a person aggrieved by the Order may in accordance with the provisions of paragraph 15 of Schedule 1 to the Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947 as extended by Section 60 of the land Compensation (Scotland) Act 1973 by application to the Court of Session within 6 weeks from that date, question its validity on the grounds (i) that the authorisation granted by the Order is not empowered to be granted or (ii) that his interests have been substantially prejudiced by failure to comply with any statutory requirement relating to the Order.

The Secretary of State may acquire the land and the rights in land to which this Notice relates by making a General Vesting Declaration
