(PROHIBITION OF DRIVING)
TRAFFIC REGULATION ORDER 1981

THE Lothian Regional Council in exercise of their powers under Section 1 of the Road Traffic Regulation Act 1967, as amended, propose to make an Order the effect of which will be to prohibit the driving of any motor vehicle (except with the permission of a police constable in uniform or a traffic warden) on the length of the road described in the Schedule hereto.

The proposed new Order will replace the existing experimental Order which is due to expire on 3rd September 1981 and, in addition, will extend the area of the ban on driving from the present two metres to that of ten metres.

A copy of the draft Order, notice of which will be published on 26th May 1981, together with (1) map showing the roads affected (2) a statement of the Council's reasons for proposing to make the Order and (3) a copy of the aforementioned Experimental Order may be examined at The Lothian Regional Council's Headquarters, George IV Bridge, Edinburgh, between the hours of 9.30 a.m. and 3.30 p.m. on Mondays to Fridays both inclusive.

Any person wishing to object to the proposed Order should send details of the grounds of objection, in writing, to the undersigned not later than 16th June 1981.
