His Royal Highness the PRINCE REGENT in Council.

It is ordered, by his Royal Highness the Prince Regent in Council, in the name and on the behalf of his Majesty, that the Parliament, which stands prorogued to Monday the twenty-third of this instant August, be further prorogued to Friday the fourth day of October next.

WHITEHALL—AUGUST 14, 1813.

His Royal Highness the Prince Regent has been pleased, in the name and on the behalf of his Majesty, to order a conge d'elire to pass the Great Seal, empowering the Dean and Chapter of the Cathedral Church of St. Paul, London, to elect a Bishop of that see, the same being void by the death of the Right Reverend Father in God, Doctor John Randolph, late Bishop thereof; and his Royal Highness has also been pleased, by his sign manual, to recommend to the said Dean and Chapter, the Reverend William Howley, Doctor in Divinity, Regius Professor of Divinity in the University of Oxford, and a Canon of the Cathedral Church of Christ in the said University, to be by them chosen Bishop of the said see of London.
