(ii) that the said goods shall be exported from the United Kingdom not later than the termination of the entitled person's tour of duty in the United Kingdom.

Whereby and by force of Sections 49(a) and 124(1) of the Customs and Excise Management Act 1979 and Article 17(2) of the Customs Duty (Personal Reliefs) Order 1970 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in Scotland who is authorised to accept service of process and to act on your behalf.
