1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Registrar's

Office (Bank Buildings) at the Bank of England on Friday, 26th February 1982 at 1.00 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday, 1st March 1982 to Friday, 5th March 1982 inclusive and will be due 91 days after date.
3. The Bills will be issued and paid at the Bank of England.
4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (Being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
5. Tenders must be made through a London Banker, Discount House or Broker.
6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of

England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

THE TRUNK ROADS (ROUTE M74) (JUNCTION 4— A723 INTERCHANGE) (TEMPORARY CLOSURE OF CARLISLE/MOTHERWELL SLIP ROAD) ORDER 1982

THE Secretary of State gives notice that he proposes to make the above order temporarily closing that length of the Carlisle/Motherwell slip road at M74/A723 Interchange (Junction No. 4) from the point on the west kerbline at which the said slip road exits from the London-Carlisle-Glasgow-Inverness Trunk Road (Route A74) to the point at

which it merges with the Hamilton/Motherwell Principal Road (Route A723), a distance of 1,000 metres.

The closure which is necessary to allow essential repairs to be carried out to the bridge carrying the slip road over the A723 will take place from 9 March 1982 until 8 June 1982.

Alternative Route for Traffic

Traffic northbound on M74 proceeding to Motherwell is to continue northwards on the M74 to Raith Interchange (Junction No. 5) leaving M74 on the south-west slip road proceeding around the roundabout and joining M74 southbound via south-east slip road. Traffic for Motherwell would then continue southwards on M74 leaving M74 via the Motherwell slip road at the Hamilton/Motherwell Interchange (Junction No. 4).

(ROUTE A80) (STRATHCLYDE REGION)
(TEMPORARY PROHIBITION OF TRAFFIC)
ORDER 1982
