### TRUNK ROADS ACT 1946

THE Secretary of State gives notice that he proposes to make the following Scheme and Order:—

1. The Maryville to West of Fullarton Road (M74) Special Road Scheme 198 for the construction of a length of special road in Strathclyde Region.
