# THE TRUNK ROADS (ROUTE A7) (HAWICK) (PROHIBITION OF WAITING AND LOADING) ORDER 1982

## THE FRESHWATER AND SALMON FISHERIES (SCOTLAND) ACT 1976

#### PROPOSALS UNDER SECTION 1: TUMMEL-GARRY CATCHMENT AREA TAYSIDE REGION
