THE TRUNK ROADS (ROUTE A8) (PROHIBITION OF SPECIFIED TURNS) (CARNBROE) ORDER 1982

THE Secretary of State gives notice that he has made the above Order which (a) prohibits any vehicle proceeding on the westbound carriageway of the Edinburgh-Glasgow (A8) trunk road, from making a right-hand turn into Carnbroe Road (b) prohibits any vehicle proceeding southwards in Carnbroe Road from making a right-hand turn onto the westbound carriageway of the Edinburgh-Glasgow (A8) trunk road and (c) prohibits any vehicle which is proceeding on the

SCOTSTON TO CANDY IMPROVEMENT
