THE TRUNK ROADS (ROUTE A702) (BROWNSBANK BRIDGE) (TEMPORARY CLOSURE) ORDER 1982

THE Secretary of State gives notice that he has made the above Order temporarily closing that length of the North of Abington-Edinburgh Trunk Road (Route A702) at Brownsbank Bridge near Candy Burn in Strathclyde Region from a point 60 metres north of the centreline of Brownsbank Bridge southwards to a point 60 metres south of the said centreline, a distance of 120 metres.

The closure which is necessary to allow repairs to be carried out to the cattle creep will take place from 19th April 1982 until 18th July 1982.

THE TRUNK ROAD (ROUTE A74)

(TEMPORARY PROHIBITION OF SPECIFIED TURNS) (CRAWFORD) ORDER 1982

THE Secretary of State gives notice that he proposes to make the above Order which will temporarily prohibit:—

- (a) any vehicle proceeding on the northbound carriageway of the London-Carlisle-Glasgow-Inverness (A74) Trunk Road in the Strathclyde Region from making a right-hand turn onto the north access road (C212) to Crawford.

With the exception of southbound traffic on the A74 entering Crawford via the north access road all other traffic should enter/exit Crawford via the south access road.
