#### TENDERS FOR TREASURY BILLS

- The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Registrar's Office (Bank Buildings) at the Bank of England on Friday, 30th April 1982 at 1.00 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.
- The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Tuesday, 4th May 1982 to Friday, 7th May 1982 inclusive and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (Being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- Tenders must be made on the printed forms which may be obtained from the Bank of England.

THE Treasury hereby given notice in accordance with paragraph 13 of the Save As You Earn Third Issue prospectuses issued by the Department for National Savings and dated 1st July 1975 and 1st April 1981 (hereinafter together called "the prospectus") that the following terms shall apply in respect of any contract issued under the prospectus which is repaid after the seventh anniversary of its starting date (hereinafter called "the seventh anniversary"). # **EXPLANATORY NOTE**

These Regulations amend Regulation 17(2) and (3) of the Supplementary Benefit (Claims and Payments) Regulations 1981.

Regulation 17(2) is amended to provide, subject to certain exceptions and to transitional provisions, for the doubling of the amount which may be deducted from weekly supplementary benefit in respect of any debt for gas or electricity and paid direct to the person or body to whom the debt is due. The amendment also provides for the amount being deducted from benefit to meet the beneficiary's continuing needs for the relevant fuel to be adjusted on review to take account of any credit balance or further debt which may have accrued in respect of the beneficiary. Regulation 17(3) is amended to make

clear that where either the beneficiary or his partner has income which is disregarded for the purposes of calculating his supplementary benefit the amount or total of the amounts deducted in respect of a fuel debt may be increased by not more than one half of the amount of the income disregarded.
