TENDERS FOR TREASURY BILLS

- The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Registrar's Office (Bank Buildings) at the Bank of England on Friday, 29th October 1982 at 1.00 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.
- The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the tenderer on any business day from Monday, 1st November 1982 to Friday, 5th November 1982 inclusive and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (Being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

- Tenders must be made on the printed forms which may be obtained from the Bank of England.
- 8. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

NOTICE OF SUBMISSION OF DRAFT REGULATIONS ENTITLED

THE SOCIAL SECURITY (CONTRIBUTIONS)

AMENDMENT REGULATIONS 1982

THE Social Security Advisory Committee give notice that they have been asked by the Secretary of State for Social Services under Section 10 of the Social Security Act 1980 to consider and report on the draft of regulations entitled The Social Security (Contributions) Amendment Regulations 1982.

A short explanatory note provided by the Department of Health and Social Security on these regulations is appended to this notice. The Committee will take into account any comments or objections made by or on behalf of people or organisations who would be affected by the regulations received by them not later than 1st December 1982. EXPLANATORY NOTE

These regulations seek to amend the Social Security (Contributions) Regulations 1979 in respect of company directors.

There have been difficulties in determining the appropriate "earnings periods" for directors in respect of their national insurance contribution liability because of their very wide variety of pay practices. This has led to anomalies in the amounts of contributions paid by directors.

The proposed regulations will give all company directors an annual earnings period, aligned with the tax year, or a pro-rata one if they are appointed part way through the year. This earnings period will apply to all earnings paid to the director by the company during the period (e.g. fees and, where appropriate, salary). They will also provide for directors' drawings in advance of fees being voted to be treated as earnings for contributions purposes; this will bring contributions arrangements into line with those for PAYE tax.

(LAMINGTON BRIDGE AND WOODEND BRIDGE) (TEMPORARY CLOSURE)

ORDER 1982

THE Secretary of State gives notice that he proposes to make the above Order temporarily closing, except for access, that length of the North of Abington-Edinburgh Trunk Road (Route A702), south of Biggar, as measured from its junction with the Glasgow-Peebles Principal Road A72 southwestwards to its junction with the Abington-Lanark-Airdrie-Cumbernauld Trunk Road (Route A73) at Duneatonfoot, a distance of 15 kilometres and including Lamington and Woodend Bridges.
