## TREASURY MINUTE dated 9th November 1983

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a

certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 9th November 1983 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at the maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.):

# WILDLIFE AND COUNTRYSIDE ACT 1981

#### NATURE CONSERVATION ORDER

NOTICE is hereby given that on 4th November 1983, the Secretary of State, acting under Section 29 of the Wildlife and Countryside Act 1981, made the Carstairs Kames Site of Special Scientific Interest (Clydesdale District) Nature Conservation Order 1983. The Order applies Section 29(3) of the Act to the lands specified in Schedule 1 to the Order and specifies, in Schedule 2 to the Order, the operations which appear to the Secretary of State to be likely to destroy or damage the area's fluvioglacial landforms.

The general effect of the Order is to place restrictions, which are prescribed in Section 29 of the Act, on the carrying out of the operations specified in Schedule 2 to the Order and which are set out in the Schedule to this notice.

The Order took effect when it was made and will cease to have effect 9 months after it was made unless the Secretary of State previously gives notice that, having considered the Order, he does not propose to amend or revoke it or that he has amended or revoked it.

Objections to, or representations about, the Order may be made to the Secretary, Scottish Development Department, Planning Division 1, New St. Andrew's House, Edinburgh EH1 3SZ before 10th December 1983. They should be made in writing and should state the title of the Order. In the case of objections, the grounds on which they are made should also be stated.
