THE Secretary of State for Scotland, by this licence issued under the terms of Article 4 of the Importation of Animal Products and Poultry Products Order 1980 (as amended) authorises subject to and in accordance with the conditions set out below the landing in Scotland of fresh/refrigerated carcases/part carcases of domestic fowls (chickens), turkeys, guinea fowl ducks and geese with/without accompanying offal and/or unaccompanied offals of chickens, turkeys, guinea fowl, ducks and geese from the Republic of Ireland (excluding the County of Monaghan) at all ports (including airports) until further notice unless revoked by the Secretary of State. Licence No. IAPPPO/GEN/80/31 dated 1st March 1980 is hereby revoked.

CONDITIONS ATTACHING TO THIS LICENCE

Each consignment must be accompanied by a certificate in accordance with the terms of the Council Directive on health problems affecting trade in fresh poultry meat 71/118 EEC as amended signed by an official veterinarian of the Republic of Ireland certifying:—

- Details of consignment, i.e. species, nature of cuts, packaging, weight;
- Address(es) and Veterinary approval number(s) of the slaughterhouse(s):
- Destination of meat, means of transport including registration/ flight No.;
- 4. Health attestation;
 - the poultry meat/packaging described above bears a mark proving that the meat comes from animals slaughtered in approved slaughterhouses;
 - (b) this meat has been passed fit for human consumption following a veterinary inspection carried out in accordance with the Council Directive of 15th February 1971 on health problems affecting trade in fresh poultrymeat;

(c) the transport vehicles or containers and the loading conditions of this consignment meet the hygiene requirements laid down in that Directive.

B. IN ADDITION FOR EACH FRESH POULTRYMEAT

Consignments must be accompanied by the following supplementary certification "The Fresh Poultry Meat has been derived from Domestic Chickens, Turkeys, Ducks, Geese or Guinea Fowl which have not been resident since 1st October 1983 in the County of Monaghan and have not been slaughtered or cut up since 1st October 1983 in premises within the County of Monaghan.

Furthermore, the Consignment detailed above has not been despatched from a cold store on the County of Monaghan".

CONDITIONS ATTACHING TO THIS LICENCE

- A. Each consignment must be accompanied by a certificate in accordance with the terms of the Council Directive on health problems affecting intra-community trade in meat products 77/99 EC signed by an official veterinarian of the Government of the Republic of Ireland.
- B. In addition for poultrymeat products each consignments must be accompanied by the following supplementary certification, Either:
 - The poultry meat products have been prepared from domestic chickens, turkeys, ducks, geese or guinea fowl and have undergone heat treatment in a hermetically sealed container with an FC value of 3.00 or more, or have undergone heat treatment in which the internal temperature is raised to at least 70 Degrees C

Or.

- (A) The poultry meat products have been prepared from domestic chickens, turkeys, ducks, geese or guinea fowl which:
 - (1) have not been resident since 1st October 1983 on premises within the County of Monaghan.

(2) have not been slaughtered or cut up since 1st October 1983 on a premises within the County of Monaghan,

And:

(B) the poultry meat products have not been produced since 1st October 1983 at a meat products plant in the County of Monaghan.

C. Any meat product imported under this licence shall be made available if so required for inspection by an Officer of the Ministry at any place nominated by him for such inspection. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection. NOTE .

This licence will not be invalidated by transit of the goods through any other country provided that if the documents are examined by Customs en route and vehicle is resealed and the documents are endorsed accordingly.

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at the maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
