Following a recent decision by a Tribunal of Commissioners, regulations were made to clarify the long-standing policy intentions that: (i) claimants are excluded from supplementary benefit for *consecutive* rather than *concurrent* periods covered by final earnings, holiday pay and/or payments in lieu of notice; (ii) final earnings etc. received early should be attributed from the day they would normally have been received; (iii) receipt of earnings for a longer period than a contract requires excludes a claimant from benefit for that longer period.

- IV. The loading of vehicles at any time will be prohibited in the length of Larch Street described at Part IV of the Schedule to the Order.

#### NOTES

- The restrictions described at Items II, III and IV above do not apply on a Sunday.
- Exceptions are generally permitted for the following purposes:—
  - to enable a person to board or alight from a vehicle and to load or unload personal luggage;
  - building operations or operations relating to maintenance, improvement or reconstruction of the roads or the laying, erection, alteration or repair of sewers or main pipes or apparatus for the supply of gas, water or electricity or any telegraphic line;
  - Police, Fire Brigade, Ambulance and certain other statutory purposes;
  - collection and delivery of postal packets by Post Office vehicles;
  - funerals (if the vehicle is in the service of a funeral undertaker);
  - professional visits by Doctors, Nurses and Midwives and Surgery Consultations by Doctors;
  - if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
  - licensed taxis at appointed stances;
