#### PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

#### NOTICE OF APPLICATION FOR A SUBMARINE PIPE-LINE WORKS AUTHORISATION

HAMILTON BROTHERS OIL AND GAS LTD hereby gives notice on behalf of itself and Hamilton Brothers Company (GB) Ltd., Hamilton Brothers Petroleum (UK) Ltd., RTZ Oil and Gas Ltd., Texaco North Sea (UK) Ltd., Blackfriars Oil Company Ltd., Trans-European Company Ltd., in accordance with the provisions of Part I of Schedule 4 of the Petroleum and Submarine Pipe-lines Act 1975 that it has made an application to the Secretary of State for Energy for the grant of an authorisation for the construction and use of submarine pipe-lines for the conveyance of crude oil and its associated hydrocarbons between Well 30/24 WW and Duncan Manifold.

#### TECHNICAL ANNEX TO PUBLIC NOTICE

#### ARGYLL/DUNCAN FIELD DEVELOPMENT

#### INFORMATION

At the request of the Secretary of State for Energy, and as agreed by the Pipelines Inspectorate, Hamilton Brothers Oil and Gas Ltd., presents the following information about the 2898 metre long, 154.5mm OD flowline.

#### Pre-Commissioning Testing

The pipeline will be tested to the satisfaction of the Pipelines Inspectorate prior to commissioning.

#### Design Pressure

The maximum pressure in the line will be less than the pressure for which the pipeline has been designed.

#### Leak Detection

Pressure and flow will be monitored at all times.

In the event of a leak being detected the pipeline pressure will be reduced to eliminate the leak. An aerial and underwater survey will be conducted to find the source of the leak.

Routine surveillance will be carried out along the pipeline route.

#### **Emergency** Action

In the event that a major break occurs in the pipeline the following emergency action will be taken:

- All oil delivery into the pipeline will be manually or automatically stopped.
- Department of Energy Pipelines Inspectorate will be notified immediately.
- (3) An underwater survey and aerial survey will be carried out to determine the location of the break.
- (4) Should pollution result from the discharge of crude oil the emergency pollution control system held in constant readiness by Hamilton Brothers Oil and Gas Ltd. and by the UK Offshore Operators Association will be mobilised.

#### Recommissioning

In the event of a pipeline break, contingency plans to be agreed with the Department of Energy Pipelines Inspectorate will be carried out for the repairing of the pipeline and proving its integrity before putting it back into service.

#### On Bottom Stability and Safety

The pipeline, if authorised, will be laid in a manner that will ensure its safety and stability under all foreseeable conditions.

#### Limits of Deviation

The Pipeline will be laid within a boundary of 100 metres on either side of the proposed route.
