WILDLIFE AND COUNTRYSIDE ACT 1981

THE Secretary of State for Scotland, having consulted the person referred to in Section 2(7) of the Wildlife and Countryside Act 1981, has made an Order under Section 2(6) of the Act banning the shooting of wild ducks and geese listed in Part I to Schedule 2 (but excluding the Capercaillie) due to severe cold weather.

The Order comes into operation at 9 a.m. on 18th January 1985 and runs until 31st January 1985 and will mainly affect wild duck and geese.

The Secretary of State will consider later whether to extend the ban on shooting beyond 31st January 1985.
