NOTICE is hereby given that the East Kilbride Development Corporation, in exercise of the powers conferred on them by Sections 3 and 7 of the New Towns (Scotland) Act 1968, made the above-mentioned Order on 11th November 1985, which has been submitted for confirmation by the Secretary of State, authorising them to purchase compulsorily for the purposes of laying out and developing the New Town of East Kilbride, the lands described in the Schedule hereto.
