THE City of Edinburgh District Council hereby give notice that on 5th December 1985 they made and confirmed an Order in terms of Section 273(3) of the Town and Country Planning (Scotland) Act 1972 to revoke part of the stopping up of Highways (Timber Bush, Edinburgh) Order 1982 which came into operation on 29th October 1982.
