#### TENDERS FOR TREASURY BILLS

- THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 13th December 1985, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.

- 3. The Bills will be issued and paid at the Bank of England.

Each Tender must be for an amount of not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent (being a multiple of one halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- Tenders must be made on the printed forms which may be obtained from the Bank of England.
- 8. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

#### GENERAL IMPORT LICENCE

THE Secretary of State for Scotland, by this licence issued under the terms of Article 4 of the Importation of Animal Products and Poultry Products Order 1980 (as amended) authorises subject to and in accordance with the conditions set out below the landing in Scotland of Pet Food (heat treated in hermetically sealed containers), from Argentina, Australia, Austria, Belgium, Botswana, Brazil, Bulgaria, Canada, Chile, Cyprus, Czechoslovakia, Denmark, Finland, France, Federal Republic of Germany, Hungary, Iceland, Italy, Kenya, Luxembourg, Namibia (South West Africa), Netherlands, New Zealand, Norway, Poland, Romania, South Africa, Swaziland, Sweden, Switzerland, United States of America, Uruguay, Yugoslavia, Zimbabwe, at all ports and airports in Scotland until further notice unless revoked by the Secretary of State.

#### CONDITIONS ATTACHING TO THIS LICENCE

Each consignment must be accompanied by a certificate signed by a duly authorised veterinary officer of the Government of the exporting country stating that the product has been heat treated in a hermetically sealed container with an FC value of 3.00 or more.

#### **NOTES**

- Nothing in this licence gives exemption from any prohibition or restriction imposed by the Imported Food Regulations 1985 or the Medicines Acts 1968 and 1971 or by any regulation superseding or amending the same, or any prohibition, regulation or restriction imposed by the Department of Trade and Industry.
- 2. This is not a Department of Trade and Industry Licence.
