A PROCLAMATION

DETERMINING THE SPECIFICATIONS AND DESIGN FOR
TWO POUND COINS COMMEMORATING THE
XIII COMMONWEALTH GAMES, TO BE HELD IN SCOTLAND,
AND PROVIDING FOR RELATED MATTERS

ELIZABETH R.

WHEREAS under section 3(1)(a), (b), (cc), (d), (dd), (f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, design, dimensions, weight and composition of coins to be made at Our Mint, to determine the remedy to be allowed in the making of such coins and the percentage of impurities which they may contain, and to direct that such coins, other than those of gold, silver, cupro-nickel and bronze, shall be current and be legal tender for payment of any amount:

And Whereas under section 6(2) of the Coinage Act 1971 We have power, by Proclamation, to prescribe the composition of the standard trial plates to be used for determining the justness of coins issued from Our Mint of any metal or mixture of metals other than gold, silver and cupro-nickel:

And Whereas it appears to Us desirable to order that, to commemorate the XIII Commonwealth Games, to be held in Scotland in the year One thousand nine hundred and eighty-six, there should be made at Our Mint in gold, in silver and in nickel brass a coin of the denomination of two pounds.

We therefore, in pursuance of the said section 3(1)(a), (b), (cc), (d), (dd), (f) and (ff) and the said section 6(2) and of all other powers enabling Us in that behalf, do hereby, by and with the advice of our Privy Council, proclaim, direct and ordain as follows:—

The Gold Coin

 (1) A new coin of gold of the denomination of two pounds shall be made, being a coin of a standard diameter of 28.4 millimetres, and circular in shape. (2) The design for the said gold coin shall be as follows:— For the obverse impression Our effigy with the inscription "ELIZABETH ' II ' DEI ' GRATIA ' REGINA ' F ' D'' and the words "TWO POUNDS", and for the reverse a St. Andrew's cross surmounted in chief by a crown triumphal overall a Thistle of Scotland and the date of the year "1986". The coin shall have a graining upon the edge.

The Silver Coins

- (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres, and a standard composition of one half fine silver and one half alloy; or millesimal fineness 500, and being circular in shape.
 - (2) In the making, of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified in subsection (1) above) shall be allowed of an amount not exceeding the following, that is to say:—
 - (a) a variation from the said standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes;
 - (b) a variation from the said standard diameter of 0.1 millimetres per coin; and
 - (c) a variation from the said standard composition of ten per mille.
 - (3) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres, and a standard composition of thirty-seven-fortieths fine silver and three-fortieths alloy; or millesimal fineness 925, and being circular in shape.
 - (4) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified in subsection (3) above) shall be

allowed of an amount not exceeding the following, that is to say:—

- (a) a variation from the said standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes;
- (b) a variation from the said standard diameter of 0.1 millimetres per coin; and
- (c) a variation from the said standard composition of five per mille.

The Nickel Brass Coin

- 3. (1) A new coin of nickel brass of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres, and a standard composition of seventy per centum copper, five and one half per centum nickel and twenty-four and one half per centum zinc, and being circular in shape.
 - (2) In the making of the said nickel brass coin a remedy (that is, a variation from the standard weight, diameter or composition specified in subsection (1) above) shall be allowed of an amount not exceeding the following, that is to say:—
 - (a) a variation from the said standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes;
 - (b) a variation from the said standard diameter of 0.1 millimetres per coin; and
 - (c) a variation from the said standard composition of two per centum copper, three quarters per centum nickel and two per centum zinc.
 - (3) The said coin may contain impurities of 0.75 of one per centum.
 - (4) The said coin shall be current and be legal tender for payment of any amount in any part of Our United Kingdom.
 - (5) The composition of the standard trial plates to be used for determining the justness of the said nickel brass coin shall be pure copper, pure nickel and pure zinc.

Design for The Silver and Nickel Brass Coins

 The design for the said silver and nickel brass coins shall be as follows:—

For the obverse impression Our effigy with the inscription "ELIZABETH. II. DEI. GRATIA. REGINA. F.D" and the words "TWO POUNDS", and for the reverse a St. Andrew's cross surmounted in chief by a crown triumphal overall a Thistle of Scotland and the date of the year "1986". The coins shall have a graining upon the edge and in incuse letters the inscription "XIII COMMONWEALTH GAMES SCOTLAND 1986", after which there shall be placed on the mark of Our Mint at Llantrisant.

 This Proclamation shall come into force on the nineteenth day of December One thousand nine hundred and eightyfive.

Given at Our Court at Buckingham Palace, this eighteenth day of December in the year of our Lord One thousand nine hundred and eighty-five and in the thirty-fourth year of Our Reign.

TREASURY MINUTE dated 18th December 1985

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 18th December 1985 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
