TRIAL OF THE PYX

VERDICT

1. WE, the undersigned, were duly sworn on 13th February 1986 before the Queen's Remembrancer, at Goldsmiths' Hall in the City of London, to assay gold, silver Maundy, silver, cupronickel and nickel brass coins of Her Majesty, which were produced to us by officers of the Royal Mint. Accounts of the Deputy Master of the Royal Mint were similarly produced to us and showed that the coins had been made by the Royal Mint in accordance with the Coinage Act 1971, a Proclamation made on 22nd June 1983 relating to silver coins of one pound, a Proclamation made on 20th December 1968, relating to coins of fifty pence, a Proclamation made on 10th February 1982, relating to coins of twenty pence and a Proclamation made on 22nd June 1983, relating to nickel brass coins of one pound and that the coins had been made and delivered into the Despatch Office of the Royal Mint between 1st January 1985 and 31st December 1985 inclusive.

- 2. In this verdict any reference to the permitted variation from standard weight, fineness, composition or diameter is to such variation from the standard weight, fineness, composition or diameter as is allowed by such Act and Proclamations.
- 3. We ascertained the number of coins in each packet produced to us and that it corresponded with the number which the officers of the Royal Mint represented the packet to contain, except that one packet of nickel brass coins of one pound contained an extra coin.
- 4. Gold Coins
 - (a) We took out one coin from each of the four packets of gold coins.
 - (b) We weighed in bulk the coins taken out and ascertained that they were on the whole within the permitted variation from standard weight, the variation being the point nought three (+0.03) of a gram above standard weight.
 - (c) After weighing those coins, we melted them into an ingot and assayed it, comparing it with the standard trial plate of gold produced to us by an officer of the Department of Trade and Industry, and we found that the metal of the ingot was within the permitted variation from standard fineness, the variation being point seven one (-0.71) parts per thousand below standard fineness.
 - (d) We weighed in bulk the residue of the gold coins remaining in the packets and ascertained that they were on the whole within the permitted variation from standard weight, the variation being point nought five (+0.05) of a gram above standard weight.
 - (e) Finally we took out of the residue two coins of five pounds, two coins of two pounds, two sovereigns and two half-sovereigns and weighed and assayed them separately. We found that each of the coins so weighed was within the permitted variation from standard weight, the variations being as follows:

for the coins of five pounds:	point nought nought four two (-0.0042) and point nought two three nought (-0.0230) of a gram below standard weight;	
for the coins of two pounds:	point nought nought one nought $(+0.0010)$ of a gram above and point nought nought three eight (-0.0038) of a gram below standard weight;	
for the sovereigns:	point nought nought two six (+0.0026) of a gram above and point nought nought six seven (-0.0067) of a gram below standard weight and	
for the half- sovereigns:	point nought nought one nine $(+0.0019)$ and point nought nought three four $(+0.0034)$ of a gram above standard weight.	
We also found that each of the coins so assayed was within the permitted variation from standard fineness, the variations being as follows:		
for the coins of five pounds:	point two nine (-0.29) and point three three (-0.33) parts per thousand below standard fineness;	
for the coins of two pounds:	point nought three $(+0.03)$ and point one eight $(+0.18)$ parts per thousand above standard fineness;	

for the point one four (+0.14) parts per sovereigns: thousand above and point three seven (-0.37) parts per thousand below standard fineness and for the half- point one nought (+0.10) and

sovereigns: point two nought (+0.20) parts per thousand above standard fineness.

5. Silver Maundy coins

(a) We took out all the coins from the packets of silver Maundy coins, weighed them in bulk and ascertained that they were on the whole within the permitted variation from standard weight, the variation being point one one (+0.11) of a gram above standard weight.

- (b) We then assayed all the silver Maundy coins, comparing them with the standard trial plate of silver produced to us by an officer of the Department of Trade and Industry, and we found that the metal of the coins was on the whole within the permitted variation from standard fineness, the variation being two point six (+2.6) parts per thousand above standard fineness.
- 6. Silver coins other than Maundy coins
 - (a) We ascertained that all the silver coins contained in the packets weighed less than five hundred grams.
 - (b) We took out all the pied forte one pound coins and weighed them in bulk and found that they were on the whole within the permitted variation from standard weight, the variation being point six (-0.6) of a gram below standard weight.
 - (c) We took out all the other one pound coins and weighed them in bulk and found that their weight did not vary from the standard weight.
 - (d) Finally, we assayed all the silver coins, comparing them with the standard trial plate of silver, and ascertained that the metal of the coins was on the whole within the permitted variation from standard fineness, the variations being for the pied forte coins two point five (+2.5) and for the other coins one point nine (+1.9) parts per thousand above standard fineness.
- 7. Cupro-nickel coins
 - (a) We ascertained that of the cupro-nickel coins contained in the packets those of each of the denominations of fifty and twenty pence weighed more and those of each of the denominations of ten and five pence weighed not more than one kilogram.
 - (b) From each packet of coins of fifty and twenty pence we took out sufficient coins and grouped them into three lots so that each lot comprised coins of the same denomination and weighed not less than nine hundred and eighty grams nor more than one kilogram.
 - (c) We then weighed each lot in bulk and found that it was on the whole within the permitted variation from standard weight, the variations being as follows:

for two lots of coins of fifty pence:	one point three $(+1.3)$ and two point two $(+2.2)$ and
for one lot of coins of twenty pence:	one point eight (+1.8) grams above standard weight.

- (d) We weighed in bulk the residue of the coins of fifty and twenty pence remaining in the packets and ascertained that they were on the whole within the permitted variation from standard weight, the variation being seventy point eight (+70.8) grams above standard weight.
- (e) We took out all the coins of ten pence and weighed them in bulk and found that they were on the whole within the permitted variation from standard weight, the variation being one point three (+1.3) grams above standard weight.
- (f) We also took out all the coins of five pence and weighed them in bulk and found that they were on the whole within the permitted variation from standard weight, the variation being point three (-0.3) of a gram below standard weight.

(g) We then assayed coins not weighing less in all than five hundred grams, comparing them with the standard trial plates of copper and nickel produced to us by an officer of the Department of Trade and Industry, and we ascertained that the metal of the coins was on the whole within the permitted variations from standard compositions, the variations being for the coins of fifty pence minus point two (-0.2) per centum of copper and plus point one per centum of nickel (+0.1), for the coins of twenty pence minus point three (-0.3) per centum of copper and plus point two (+0.2) per centum of nickel and for the coins of ten and five pence minus point four (-0.4) per centum of copper and plus point three (+0.3) per centum of nickel.

- (h) We measured the diameter of twenty of each of the coins of fifty, twenty, ten and five pence and ascertained that the average diameter of the coins of each denomination was within its permitted variation from standard diameter, the only variations being for the coins of fifty pence point nought three (+0.03) of a millimetre more than the standard diameter, for the coins of twenty pence point nought one (-0.01) of a millimetre less than the standard diameter and for the coins of five pence point nought four (+0.04) of a millimetre more than the standard diameter.
- 8. Nickel brass coins
 - (a) We ascertained that the nickel brass coins of one pound contained in the packets weighed more than one kilogram.
 - (b) We took out from each packet sufficient coins and grouped them into eight lots each weighing not less than nine hundred and eighty grams nor more than one kilogram.
 - (c) We then weighed each lot in bulk and ascertained that it was on the whole within the permitted variation from standard weight, the variations being as follows:

point four (+0.4), point six (+0.6), point seven (+0.7), one point nought (+1.0), one point nought (+1.0), two point one (+2.1), two point two (+2.2), and two point six (+2.6)grams above standard weight.

- (d) We weighed in bulk the residue of the coins of one pound remaining in the packets and ascertained that they were on the whole within the permitted variation from standard weight, the variation being two hundred and fifty point two (+250.2) grams above standard weight.
- (e) We then assayed coins not weighing less in all than five hundred grams, comparing them with the standard trial plates of copper, nickel and zinc produced to us by an officer of the Department of Trade and Industry, and we ascertained that the metal of the coins was on the whole within the permitted variation from standard composition, the variations being minus point five (-0.5) per centum of copper, plus point seven (+0.7) per centum of nickel and minus point six (-0.6) per centum of zinc.
- (f) Finally, we measured the diameters of twenty coins and found that the average diameter was within the permitted variation from standard diameter, the variation being point nought two (-0.02) of a millimetre less than the standard diameter.
