## MISUSE OF DRUGS ACT 1971

#### IMPORTATION AND EXPORTATION LICENCE

IN pursuance of Section 3(2)(b) of the Misuse of Drugs Act 1971, the Secretary of State (as regards Great Britain) and the Department of Health and Social Services for Northern Ireland (as regards Northern Ireland) hereby licence, with effect from 1st March 1987, and subject to the terms and conditions specified below, the importation and exportation of:

> (a) any controlled drug specified in Part I of the Schedule to this licence by a person who is entering or leaving the United

Kingdom where that drug is intended for administration for dental or medical purposes to himself or to a member of his household who is unable to administer the drug himself and who is travelling with that person at the time of importation or exportation;

- (b) any controlled drug specified in Part II of the Schedule to this licence by a doctor of medicine who is entering or leaving the United Kingdom:
  - (i) with a patient for whose treatment during that journey to or from the United Kingdom the doctor considers the drug may be necessary;
  - (ii) for the purpose of immediately leaving, or within the next three days entering, the United Kingdom with such a patient; or
  - (iii) within three days after its lawful exportation by him when leaving, or immediately after its lawful importation by him when entering, the United Kingdom with a patient for whose treatment during that journey from or to the United Kingdom the doctor considered the drug might be necessary.

The terms and conditions attached to this licence are:

1. The amount of any controlled drug imported under this licence shall not exceed:

- (a) on each occasion on which it is imported or exported, the quantity specified in respect of that drug in column 2 of the Schedule to this licence;
- (b) in any period of thirty days, twice that quantity.
- 2. This licence does not apply:
  - (a) to any controlled drug which is not contained in a medicinal product within the meaning of the Medicines Act 1968;
  - (b) unless the controlled drug is under the direct personal supervision of the person importing or exporting it;
  - (c) to the exportation of any controlled drug by a person who is not lawfully in possession of the drug.

It is hereby directed that, notwithstanding any provision in Regulations under Section 10 of the Misuse of Drugs Act, with respect to record-keeping, no record is required to be kept of any quantity of controlled drug imported or exported under this licence.

This licence shall remain in force until revoked by Order of the Secretary of State, and the Department of Health and Social Services for Northern Ireland.

- Para. 2(f) : the composition, temperature and other essential characteristics of the waters remain stable within the limits of natural fluctuation.

**OPENCAST COAL ACT 1958** 

NOTICE is hereby given that the National Coal Board intend to submit an application entitled the Dalquhandy Application 1987 to the Secretary of State for an authorisation under Section 1 of the Opencast Coal Act 1958, to work coal by opencast operations or to cause or permit coal to be worked by such operations, and for an Order under Section 15 of that Act suspending public rights of way. The land which the National Coal Board require to occupy in this connection and the rights of way to which the application for the Order relates are described below. #### DESCRIPTION OF LAND

The land which extends to about 1027 hectares (2537 acres) is situated south and west of the village of Coalburn in the Clydesdale District in Strathclyde Region. The main body of the land extends from the Cumberhead Road eastwards to Long Plantation and West-toun. The southern boundary is formed in part by the Poniel Water and in part by the lower slopes of Arkney Hill. An access corridor connects the main body of the land to the Poniel Interchange on the Wellburn-Poniel section of the M74 Motorway.

#### DESCRIPTION OF PUBLIC RIGHTS OF WAY

- Part of a pedestrian right of way which runs from Cumberhead Road, opposite the entrance to Over Stockbriggs, in a generally easterly then south-easterly direction to Shoulderigg Road, being that part which runs from a point about 340 metres east of Cumberhead Road for a distance of about 850 metres to its junction with Shoulderigg Road.

# TREASURY MINUTE dated 11th February 1987

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 11th February 1987 and until the coming into operation of a further determination:

- The rate of interest applicable to any such fixed rate loan will be I. that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);


