2 to 5 companies	. . .	double the single company rate
6 to 10 companies	. . .	treble the single company rate

Pre-payment is required for these rates. In the case of notices under H. above pre-payment of £23.00 (£20.00 + VAT) is required. You will be invoiced for any balance.
