The Lothian Regional Council (Box Junctions, Edinburgh) Order 1978 is amended so that its provisions restricting the driving of any vehicle into a boxed area of carriageway at or near a road junction are extended to two additional such boxed areas on the north side of Princes Street at Castle Street and Frederick Street.
