IN exercise of the power conferred by regulation 6(c) (1) of the Control of Pesticides Regulations 1986 (SI 1986/1510) and of all other powers enabling them in that behalf, the Minister of Agriculture, Fisheries and

Food, and the Secretary of State, hereby jointly give their consent to the use of any approved product containing dinoseb-in-oil (hereinafter referred to as "an approved product") subject —

- (a) to the Conditions of Consent 2 (Use), and
- (b) to the conditions set out below

Conditions

1. No person shall use an approved product unless:

- (a) such use occurs between 20th April 1987 and 29th May 1987 inclusive;
- (b) that person is, or is a male servant or agent of, one of the following contractors:
 - (i) Chemical Spraying Company Ltd (1)
 - (ii) D M Carnegie (2)
 - (iii) East of Scotland Farmers Ltd (3)
 - (iv) D & E Greig (Contractors) (4)
 - (v) J W Miller (5)
 - (vi) J & I Reid (Contractors) (6)

and if such a servant or agent, is a volunteer who has been informed of the possible risks, has been issued with the HSE leaflet entitled "Poisoning by Pesticides — First Aid" (HSE MS (B) 7), has been instructed to report any staining of the skin during and after spraying, and who will make himself available for medical examination if such staining should occur;

- (c) such use occurs on vegetative canes of raspberries of the Glen Clova variety grown in Scotland in an area not exceeding 1200 hectares, such canes not to exceed 20cm in height;

(d) such use occurs:

- (i) once only;
- (ii) with equipment owned or hired by one of the contractors specified in Condition 1(b) above; such equipment to have been made available at least 7 days before use for checking, inspection and testing by male officers of the Department of Agriculture and Fisheries for Scotland or Inspectors of the Health and Safety Executive authorised for the purpose;
- (iii) at a minimum dilution rate of 250 grams of that approved product per litre;
- (iv) at a rate of application of 450 to 1100 litres of that approved product diluted in accordance with condition 1(d)iii above per hectare;
- (v) as a high-volume spray application, with spray to run off;

- (e) that person, for the purpose of mixing, preparing or spraying the approved product, uses systems which so far as is reasonably practicable avoid spillage or contamination;

(f) he wears the following equipment;

- (i) coveralls of Saranex Laminated Tyvek or of a material offering an equivalent level of protection, to be disposed of if more than lightly contaminated;

- (ii) gloves of viton or a material offering an equivalent level of protection, that person to have least two pairs, to be changed at intervals of no more than three hours, each pair to be washed between periods of use and disposed of if more than lightly contaminated;

- (iii) a disposal respirator, conforming to British Standard 6016 Type 2;

- (iv) the equipment specified in Conditions 1(f)(i) to (iii) above not be used for other activities, to be disposed of safely when no longer required and not be taken home.

- (g) that person ensures that public rights of way are not affected either during spraying or for a period of not less than 24 hours thereafter and that warning notices are posted;

- (h) that person ensures that areas sprayed are not re-entered for a period of five days unless protective clothing of the type specified in Condition 1(f)(i) to (iii) above is worn;

- (j) that person, being a contractor specified in Condition 1(b)(i) to (vi) above;

- (i) carries out a visual check at the end of each shift, for the purpose of identifying possible contamination, on workers carrying out spraying;

- (ii) suspends from work immediately and at any time any worker believed to have been contaminated; and

- (iii) ensures, should such contamination occur, that medical advice is sought;

- (iv) agrees to on-the-spot monitoring by authorised officers of the Department of Agriculture for Scotland or the Health and Safety Executive.

2. The requirements of the Poisonous Substances in Agriculture Regulations 1984 (SI 1984/1114), in that they relate to the use of an approved product, should be complied with.

3. Staff of the East of Scotland College of Agriculture shall ensure that contractors specified in Condition 1(b) above, are made fully aware of Conditions 1 and 2 above prior to the commencement of spraying and to coordinate the work thereafter.

4. The Department of Agriculture and Fisheries for Scotland shall in writing draw to the attention of the contractors specified in Conditions 1(b) above (i) the conditions specified in Conditions 1 and 2 above, prior to the commencement of spraying; and (ii) to the penalties under the Food and Environment Protection Act 1985 and the Poisonous Substances in Agriculture Regulations 1984, for using pesticides contrary to the conditions prescribed therein, and other the Control of Pesticides Regulations 1986 and the Consents made under those regulations.
