HEALTH MARK : CHILE

THE Secretary of State for Scotland in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1985 (SI 1985, No 913), gives notice that he hereby recognises, subject to the conditions hereinafter set out, the health mark described in Part 1 of the Schedule hereto for the importation from Chile of fresh meat as showing:-

- (a) that the fresh meat to which it relates was derived from mammals inspected before and immediately after death, and passed in accordance with criteria satisfactory to the Secretary of State, and
- (b) that the dressing, packing and other preparation of the fresh meat was carried out with all necessary precautions for the prevention of danger to health.

The said health mark is recognised subject to the following conditions:-

- i. Recognition applies only to fresh meat imported from Chile but does not apply to any such meat derived from mammals killed when wild.
- ii. Where the health mark is in the form of a stamp or label, recognition will apply only if the stamp or label has not in any other circumstances or on any other occasion been used as a health mark.

THE Secretary of State for Scotland in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1985 (SI 1985, No 913), gives notice that he hereby recognises, subject to the conditions hereinafter set out, the health marks described in Part 1 of the Schedule hereto for the importation from Yugoslavia of meat and meat products as showing:-

- that the fresh meat to which they relate, or the meat from which the meat product to which they relate was prepared, was derived from mammals or birds inspected before and immediately after death, and passed in accordance with criteria satisfactory to the Secretary of State, and
- that the dressing, packing and other preparation of the fresh meat or meat product was carried out with all necessary precautions for the prevention of danger to health.

The said health marks are recognised subject to the following conditions:-

- recognition applies only to fresh meat and meat products imported from Yugoslavia but does not apply to any such meat and meat products derived from mammals or birds killed when wild;
- recognition of the health marks is restricted to meat and meat products in which levels of Caesium 134 and 137, taken together, do not exceed 600 Bq/kg;
- where the health marks are in the form of stamps or labels, recognition will apply only if the stamps or labels have not in any other circumstances or on any other occasion been used as a health mark.

RATES OF INTEREST ON LOANS BY THE PUBLIC WORKS LOAN COMMISSIONERS TO LOCAL AUTHORITIES

NOTICE

TREASURY MINUTE dated 8th April 1987

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quota at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 8th April 1987 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
