#### **ORDER 1987**

The Order which is required to allow roadworks to be carried out will necessitate from time to time the restriction of traffic by carriageway or lane closures over a period up to 13th May 1988.

While such closures are in operation traffic will be confined to a single lane width, with or without opposing traffic on the adjacent lane.
