- Use: 1. To be used in accordance with the aerial application leaflet notified to the approval holder. Maximum application rate 600 ml 'Dicofen' plus 400 ml diesel oil per ha by means of 6 or 8 units of 'Micron' heads each with 30 discs per head delivering droplets of a VMD of 50 microns.
 - 2. Allocation of this approval to any aerial operator should be in the form laid down in Appendix B of the Aerial Application Certificate. Full reports of all aerial operations (including details of any incidents involving people, livestock or wildlife) should be made to PRSD (Pesticides Registration and Surveillance Department, Harpenden Laboratory, Hatching Green, Harpenden, Herts AL5 2BD) in due course.
 - 3. The additional conditions under Schedule 4 Regulation 6(c) (ii) and Consent 2 apply to this approval. An exception is made under condition 10 of Consent 2 in that aerial application is permitted when the wind velocity at the height of application does not exceed an average of 13 knots and gusts do not exceed 20 knots. This is subject to endorsement by the Civil Aviation Authority.
 - All spraying within 500 m of a habitation or ecologically sensitive area (including SSSIs) will only be carried out if the wind is blowing the spray away from that quarter.
 - 5. Protective Clothing: wear suitable protective gloves and face protection (faceshield) when handling the concentrate.
 - 6. The Forestry Commission must consult with the local office of the Nature Conservancy Council before spraying individual forest blocks in order to prevent damage to SSSIs and ecologically sensitive areas.
 - The Forestry Commission must consult with the water abstraction authorities and the Purification Boards in order to arrange for temporary water supplied where deemed necessary.
 - The Chief Medical Officers and Chief Environmental Officers for the areas concerned should be informed of the details of the programme.
 Location of the aerial areas sprayed (if less than that notified) should be sent to PRSD for information.
 - 9. The Forestry Commission should inform neighbours; landowners; tenants (including schools and hotels) and other local interested parties before spraying.

- *Achentoul Ecologically sensitive area to the west of Achentoul block. Trees within 500 m of Loch Lucy are not to be sprayed. TREASURY MINUTE dated 3rd June 1987

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quotas at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 3rd June 1987 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- III. The rates of such interest shall be:-

PWLB Non-quota B Rate loans will bear interest at 1 per cent above the corresponding Non-quota A rates.

The amount which a local authority borrows within its annual quota will bear interest at the appropriate rate in the quota set of rates. Authorities may borrow further sums at quota rates at the discretion of the Public Works Loan Commissioners. Other borrowing beyond the quota entitlement will be at the appropriate rate in the non-quota set of rates.

My Lords concur.
