DISEASES OF FISH ACT 1937 (AS AMENDED)

NOTICE is hereby given that the Secretary of State has made the Diseases of Fish (Designated Area) (Scotland) (No. 14) Order 1987. This Order declares the area comprising the salmon rearing cages situated in Loch Kanaird, Ross-shire at the location known as Ardmail and occupied by Wester Ross Salmon Ltd to be a designated area for the purposes of the Diseases of Fish Act 1937 (as amended), and provides for the control of the movement of live fish, live eggs of fish and food stuff for fish out of the area. The Order will come into force on 26th September 1987.
