HEALTH MARK : MALTA

THE Secretary of State for Scotland in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1985 (SI 1985, No. 913), gives notice that he hereby recognises, subject to

the conditions hereinafter set out, the health marks described in Part I of the Schedule hereto for the importation from Malta of fresh meat as showing:—

- (a) that the fresh meat to which it relates, was derived from mammals inspected before and immediately after death and passed in accordance with criteria satisfactory to the Secretary of State; and
- (b) that the dressing, packing and other preparation of the fresh meat was carried out with all necessary precautions for the prevention of danger to health.

The said health mark is recognised subject to the following conditions:—

- (i) recognition applies only to fresh meat imported from Malta but does not apply to any such meat derived from mammals killed when wild;
- (ii) where the health mark is in the form of a stamp or label, recognition will apply only if the stamp or label has not in any other circumstances or on any other occasion been used as a health mark.

Recognition of the health mark is restricted to the extent shown in Part 2 of the Schedule hereto.

## SCHEDULE

### Part 1

For fresh meat of domestic bovine animals (including buffalo), pigs, sheep, goats and solipeds the health mark shall consist of:—

A stamp or label bearing the following details within an oval surround 6.5 cm wide by 4.5 cm high:—

on the upper part:

the name MALTA in capitals or, if appropriate, the set of initials approved for that country under the International Convention on Motor Vehicle Registration, viz: M;

in the centre:

the veterinary approval number of the establishment, which shall be from the list in Part 2 of this Schedule.

The letters must be 0.8 cm high and the figures 1 cm high. The seal may include an indication of the official veterinarian who carried out the health inspection of the meat.

Note: Imports of meat and meat products from certain countries are restricted and in some cases prohibited on animal health grounds by the Importation of Animal Products and Poultry Products Order 1980, as amended. ### NATURAL MINERAL WATERS REGULATIONS 1985

NOTICE is hereby given that, in response to an application from Sohat High Spring, Falougha, Lebanon, the Minister of Agriculture Fisheries and Food has granted recognition to the water originating at Sohat High Spring, in accordance with the provisions of Schedule 1 Part II of the Natural Mineral Waters Regulations 1985.

The Minister has granted recognition on the grounds that the Lebanese Ministry of Health and Social Affairs has certified that it is satisfied as to the matters set out in paragraph 2 of Schedule 1, Part 1 of the Regulations and that regular checks will be made on the matters specified in Schedule 2 of the Regulations.

This recognition is also subject to the understanding that the Lebanese Ministry of Health will continue to be able to carry out the regular checks at the point of exploitation of the source and that if this should cease to be possible, the Sohat management will immediately cease export of the water to the United Kingdom.

The recognition of the water took effect from 5th November 1987.

### AMENDMENTS TO THE EUROPEAN PHARMACOPOEIA

ON behalf of the Ministers, that is to say the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, and on behalf of the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, it is hereby declared under section 65(8) of the Medicines Act 1968 that the amendments to the Second Edition of the European Pharmacopoeia referred to in the Schedule hereto and published in accordance with the Convention on the Elaboration of a European Pharmacopoeia, are to have effect for the purposes of the said section 65 on 1st January 1988.

### SCHEDULE

#### Fascicule 3

#### *Benzylpenicillin Potassium* (No. 113)

Replace the test for absorbance by the following:

*Absorbance* (V.6.19) Dissolve 94.0 mg in water and dilute to 50.0 ml with the same solvent. Measure the absorbance of the solution at 325 nm, 280 nm and at the maximum at 264 nm, diluting, if necessary, the solution for the measurement at 264 nm. The absorbances at 325 nm and 280 nm do not exceed 0.10 and the absorbance at the maximum at 264 nm is 0.80 to 0.88, calculated on the basis of the undiluted (0.188 per cent m/V) solution. Verify the resolution of the apparatus (V.6.19); the ratio of the absorbances is not less than 1.7.

**Benzylpenicillin Sodium (No. 114)**

Replace the test for absorbance by the following:

**Absorbance (V.6.19)** Dissolve 90.0 mg in water and dilute to 50.0 ml with the same solvent. Measure the absorbance of the solution at 325 nm, 280 nm and at the maximum at 264 nm, diluting, if necessary, the solution for the measurement at 264 nm. The absorbances at 325 nm and 280 nm do not exceed 0.10 and the absorbance at the maximum at 264 nm is 0.80 to 0.88, calculated on the basis of the undiluted (0.180 per cent M/V) solution. Verify the resolution of the apparatus (V.6.19); the ratio of the absorbances is not less than 1.7.

TREASURY MINUTE dated 18th November 1987

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quotas at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 18th November 1987 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the

loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;

- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
