PESTICIDE APPROVALS

UNDER the Food and Environment Protection Act 1985 and Regulation 5 of the Control of Pesticides Regulations 1986, the Minister of Agriculture, Fisheries and Food, and the Secretary of State, acting jointly, have amended the conditions of approval for certain products as shown in the attached annexes for one year only with effect from 1st January 1988.

ANNEX I

NON-EDIBLE CROPS AND PLANTS

Pesticides approved for use on any growing crop may be used in agriculture and horticulture and in forest nurseries when neither the crops or plants, nor the fruits or product of those crops or plants, will be consumed by humans or livestock, provided that:

- (a) the safety precautions; and
- (b) the instructions relating to use,

which are specified on the labels or accompanying leaflets of the pesticide products are observed in the particulars which Ministers may from time to time specify. Growers and operators are required to satisfy themselves that the proposed use will give the protection intended and will be without adverse effects to the crop, to other crops, and is consistent with the conditions on use specified in Consent No 2 (Use) (London Gazette, 6th October 1986).

ANNEX II

CROPS USED PARTLY OR WHOLLY FOR CONSUMPTION BY HUMANS OR LIVESTOCK

Pesticide products may be used on commercial horticultural or agricultural holdings on the crop listed below in the first column if they have been provisionally or fully approved for use on the crop(s) listed opposite them in the second column, provided that

- (a) the safety precautions
- (b) the instructions relating to use

specified for the crop(s) in the second column on the label or accompanying leaflet are observed in the particulars which Ministers may, from time to time specify. Where the proposed use involves crops in the first column being grown under protection this may only take place where the respective crop(s) in the second column are also grown under protection.

Growers and operators are required to satisfy themselves that the proposed use will give the protection intended, and will be without adverse effects to the crop, to other crops, and is consistent with the conditions on use specified in Consent No 2 (Use) (London Gazette 6th October 1986).

FAIR TRADING ACT 1973
REFERENCE TO MONOPOLIES AND
MERGERS COMMISSION

Supply of gas through pipes to certain persons.

THE Director General of Fair Trading in exercise of his powers under sections 47(1), 49(1) and 50(1) of the Fair Trading Act 1973 hereby refers to the Monopolies and Mergers Commission the matter of the existence or the possible existence of a monopoly situation in relation to the supply in Great Britain of gas through pipes to persons other than tariff customers within the meaning of Part I of the Gas Act 1986.

The Commission shall investigate and report on the question whether a monopoly situation exists and, if so:

- by virtue of which provisions of sections 6 to 8 of the said Act that monopoly situation is to be taken to exist;
- in favour of what person or persons that monopoly situation exists;
- whether any steps (by way of uncompetitive practices or otherwise) are being taken by that person or those persons for the purpose of exploiting or maintaining the monopoly situation and, if so, by what uncompetitive practices or in what other way;

- whether any action or omission on the part of that person or those persons is attributable to the existence of that monopoly situation and, if so, what action or omission and in what way it is so attributable; and
- whether any facts found by the Commission in pursuance of their investigations under the preceding provisions of this paragraph operate, or may be expected to operate, against the public interest.

The Commission shall report upon this reference within a period of 9 months from the date hereof.

7. To provide for the transfer of liabilities, saving of agreements etc., the construction of bequests in favour of the existing Company and for the continuation of the terms and conditions of those employed by the existing Company and the degrees of membership held at the time of transfer.
8. To provide for the dissolution of the existing Company.
9. Other incidental and miscellaneous purposes.
