#### CONDITIONS ATTACHING TO THIS LICENCE

A. Each consignment must be accompanied by a certificate signed by a duly authorised veterinary officer of the Government of the exporting country stating that:—

1. during processing the spray dried blood powder has been subjected to a heat treatment of: a minimum temperature of 220°C for a period of at least 10 seconds.
2. after heat treatment had been completed every precaution was taken to ensure that the blood powder was not contaminated in any way prior to shipment;
3. a. for packaged materials: the blood powder has been packed in new containers (bags or sacks).

OR

b. for bulk consignments: before the blood powder was loaded into any vehicle or container or hold of a barge for conveyance to the port of shipment to Great Britain, the said vehicle or container or hold of the vessel was disinfected using a disinfectant approved by the Government of the exporting country as a general purposes disinfectant.

B. Any blood powder imported under this licence shall be made available for inspection and sampling if so required by an Officer of the Department at any place nominated by him for such inspection. The importer or his agent shall afford all assistance necessary to such an Officer to enable him to carry out the inspection in such manner as he shall determine and the importer shall be responsible for meeting any costs of carrying out such an inspection.

#### NOTES

1. Nothing in this licence gives exemption from any prohibition or restriction imposed by the Imported Food Regulations 1984 or the Medicines Acts 1968 and 1971 or by any regulation superseding or amending the same, or any prohibition, regulation or restriction imposed by the Department of Trade and Industry.
2. This is not a Department of Trade and Industry Licence.
