#### FRESHWATER AND SALMON FISHERIES (SCOTLAND) ACT 1976 PROTECTION ORDERS

THE Secretary of State for Scotland, in pursuance of paragraph 10 of Schedule 1 to the Freshwater and Salmon Fisheries (Scotland) Act 1976, hereby publishes the following list of prescribed areas which are the subject of protection orders under the Act:—

- Those parts of Borders, Lothian and Strathclyde Region lying within the catchment area of the Rivers Tweed and Eye and described in the Rivers Tweed and Eye Protection Order 1980 (SI 1980/400) as renewed by the Rivers Tweed and Eye Protection (Renewal) Order 1988 (SI 1988/1913).
- Those parts of the catchment areas of the Rivers Spey, Spean and Tummel lying within Highland and Tayside Regions and described in the Upper Spey and Associated Waters Protection Order 1982 (SI 1982/377) as renewed by the Upper Spey and Associated Waters Protection (Renewal) Order 1988 (SI 1988/374).
- The whole of the catchment area of the River Tummel upstream from its confluence with the River Tay at Ballinluig and lying within Tayside, Highland and Strathclyde Regions, but excluding that part of the catchment area of Loch Erich lying within Highland Region — all as described in the River Tummel Catchment Area Protection Order 1983 (SI 1983/390) as renewed by the River Tummel Catchment Area Protection (Renewal) Order 1988 (SI 1988/1733).
- That part of the catchment area of the River Lunan lying within Tayside Region and described in the River Lunan Catchment Area Protection Order 1983 (SI 1983/391) as renewed by the River Lunan Catchment Area Protection (Renewal) Order 1988 (SI 1988/1734).
- The whole of the catchment area of the River Tay which lies within Tayside and Central Regions upstream of its confluence with, and including the catchment area of, the Annaty Burn, but excluding the catchment areas of the Rivers Tummel and Isla — all as described in the River Tay Catchment Area Protection Order 1986 (SI 1986/1590).
- Within Strathclyde Region, the whole of the catchment area of the Rivers Annick, Irvine, Gogo Water, Noddsdale Water and certain other waters and the part of the catchment area of the River Garnock which includes the waters above the march fence to the south of Dalgarnen Mill and the Lugton Water above the footbridge at Montgreenan Mains — all as described in the West Strathclyde Protection Order 1988 (SI 1988/1516).

The orders provide that during the specified periods fishing for or taking freshwater fish in the inland waters in the areas prescribed without legal right or without permission from a person having such a right is prohibited.

CONSTRUCTION OF HIGH PRESSURE PIPELINES

A copy of the notices, and of the accompanying maps delineating the routes which the proposed pipelines are to take may be inspected free of charge between 10 a.m. and 4 p.m. Monday to Friday in the Library of the Office of Gas Supply, Southside, 105 Victoria Street, London SW1E 6QT (telephone 01 828 0898 for an appointment). Copies may also be purchased from this Library at a cost of £1 for up to and including five pages and £0.10 per page thereafter (including VAT), by personal callers between the times given above, or by postal request accompanied by cheque made payable to the Office of Gas Supply.

Sections 20(4) and (5) of the Gas Act 1986 provide that the Director General of Gas Supply may give directions as to the capacity of a proposed pipeline and as to the cost of its construction if satisfied in the light of representations:—

- that a demand exists or is likely to arise for the conveyance of gas of, or of a kind similar to, the kind specified in the Notice above referred to relating to that proposed pipeline; and
- that the routes along which the gas will require to be conveyed will severally be, as to the whole or any part thereof, the same or substantially the same as the route or any part of the route so specified.

TREASURY MINUTE dated 21st March 1989

THE Lords Commissioners of Her Majesty's Treasury read Section 3(2) of the National Loans Act 1968 (1968 C.13 as amended) whereby any sums borrowed from the Public Works Loan Commissioners shall bear interest at such rates as the Treasury may determine from time to time in accordance with Section 5 of the said Act.

My Lords understand that the Public Works Loan Commissioners will be operating arrangements under which local authorities are permitted to borrow from the Commissioners up to a specified quota at a certain fixed rate of interest and in excess of such quotas at one of two higher fixed rates.

In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 22nd March 1989 and until the coming into operation of a further determination:

- The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.) or by instalments of equal repayments of the principal and interest paid thereon (E.R.);

EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY

The Edinburgh-Berwick Upon Tweed Trunk Road (A1) (Tower to Dunglass Diversion) (Extinguishment of Public Rights of Way) Order 1989 which authorises the extinguishment of a length of the public right of way, not being a vehicular right of way, in the District of Berwick in Borders Region between Cockburnspath and Cove Farm and the provision of an alternative public right of way due to the construction of the Tower to Dunglass Diversion.
